### **FAQs**

## I want to abide by the policy, but don't know where the gaming area is.

- No one under the age of 21 is permitted to game or be present in the gaming area.
- Public walkways outside the gaming area are designated with tile flooring.
- Minor and parents with children should avoid passing through gaming area and should always be
  moving on tile paths. We do no permit children to stand on a tile path next to an adult engaged in
  gaming nearby.
- We are introducing increased signage to help customers better identify the relevant borders.

## Why can't I leave my children in the public area while I play?

It is against our policies for children to be unaccompanied anywhere in our resort.

#### How does the unattended child/minor policy work? How can I play if I have my kids with me?

- You can't. Children cannot be left alone while a parent is engaged in gaming, even nearby.
- Unaccompanied children are not permitted on property at any time and will be approached by Security to help find their parents.
- We consider children to be anyone under the age of 16.

#### But I am two seats away at a slot machine. I can see them and talk to them. They are not unaccompanied.

• We deem that to be unaccompanied under our policies as the adult's attention is on gaming and not necessarily the child.

# Isn't a late-night age restriction a step too far? Isn't this discrimination against young people?

- Not at all. After midnight, the offerings of our resort namely the casino and outlets that serve alcohol
   are already restricted to persons over 21.
- We are making accommodations for hotel guests and those attending late showings in Regal Cinemas.
- We are taking these steps to protect the guest experience for those that are of age.

#### How will you enforce the midnight to 8 am restriction to 21+?

- No one under 21 is permitted on property between 12 am midnight and 8 am.
- Hotel Guests and Regal Cinemas customers will be asked to show a hotel room key or a valid movie ticket stub.
- After midnight, resort entry points will be limited to Plaza entrance and Self-Park/Valet.
- For the convenience of late-night guests and to avoid repeated ID checks, hand-stamps will be available to casino/bar/restaurant patrons once age has been verified.
- ID checks and hand-stamps will allow staff to quickly identify those who are already age-verified.

#### Bill's Diner is the only place serving food that late.

- We are implementing this policy to maintain a comfortable resort atmosphere for the entire resort.
- We are protecting the guest experience for those who are of age.
- We are enforcing our company policies and Massachusetts law.
